

Bombay School 87th Calf Club Day Raffle 2024: Terms and Conditions

The Bombay School 87th Calf Club Day Raffle 2024 (**raffle**) is promoted by the Home and School Team of Bombay School, 35 Papparata Road RD1 Bombay, 2675 (**Bombay School**). Home and School operates under the authority of the Board of Trustees of Bombay School.

These terms, together with any entry information and/or additional terms and conditions specified by Bombay School (**Terms**), apply to the raffle, and are a contract between each entrant (you) and Bombay School.

- Term:** The raffle starts and finishes on the dates specified by Bombay School at the time of entry. The closing date and time for the raffle is Saturday 21 September 2024 at 11.59am. Entries received outside of this time will not be entered into the draw and all monies received for those entries will be treated as a donation. The winning entries will be selected from all entries received by the closing date and time. Only entries for which full payment has been received will be eligible to win a prize.
- In the event the raffle cannot be drawn on Saturday 21 September 2024 at 1pm, then the raffle will be drawn on Tuesday 24 September 2024 under the same Terms.
- Prizes:** There are four (4) prizes to be won:

Bombay School will not be responsible for any Gift Card that may be lost, stolen or damaged. Recipients must adhere to the T&Cs of the Voucher/Gift Card provider.

4. The prizes are not transferable or redeemable for cash and all components of the prizes must be taken together. Some or all components of the prizes may be subject to availability, as well as additional terms and conditions set by third parties. Prize winners are responsible for arranging and paying for all costs associated with the prize that are not explicitly stated by Bombay School at the time of entry. Bombay School may replace the prize with another prize of equivalent or greater value if the prize becomes unavailable for reasons outside Bombay School's reasonable control. Where the prize is to be delivered to the winner, the prize must be delivered to a New Zealand address. Bombay School makes no warranties about the prize (including as to its quality or fitness for purpose).
5. **Who may enter:** To enter the raffle, you must meet any entry criteria specified by Bombay School, and comply with these Terms.
6. **How to enter:** The purchase of a raffle ticket for \$10 and the entry of your contact details as requested on the ticket butt. If you do not follow the entry instructions specified by Bombay School and otherwise comply with these Terms, you may be disqualified. Incomplete entries, including but not limited to illegible writing on the ticket butt and no contact details provided, may not be accepted. Generally, entries may not be modified after submission.
7. **Number of tickets:** The raffle is limited to 3000 tickets (numbered 1 - 3000). You may purchase unlimited tickets. The published ticket price includes GST.
8. **Winner:** Unless otherwise specified, the winner(s) of the prizes will be drawn randomly, under police supervision, from a barrel comprising all valid entries on the date specified by Bombay School at the time of entry. Once a ticket butt has been drawn it will not be returned to the barrel for further prize draws. The first four (4) ticket butts drawn will be the winners, Prize 1 is allocated to the first ticket butt drawn, prize 2 to the second and so on until 4 tickets butts are drawn.
9. The person named on the drawn ticket butt will be the only person entitled to the prize. Identification will be required to receive the prize. If the person named on the drawn ticket butt is under the age of 18 years then a parent or guardian may claim the prize on behalf of the winner of the prize.
10. **Contacting the winner:** The winners of the prizes will be announced after determination. The names of the winners will be published in the Bombay School Newsletter and website, and in the Franklin County News on 26 September 2024. No contact details will be published for each winner. Bombay School will take reasonable steps to contact the winners by using the contact details provided at the time of entry. If Bombay School cannot contact a winner within 28 days after the winner is announced or if the winner is otherwise unable to accept the prize, then the winner will forfeit the prize and Bombay School may select a new winner under the same Terms.
11. **Entries:** All entries received by Bombay School will become the property of Bombay School. In addition, by entering the raffle, you agree that Bombay School may use your name and photograph for promotional purposes without compensation.
12. **Privacy:** Bombay School may collect and use personal information about you (including your name, contact details, and any other personal information you provide in connection with your entry) for the purpose of administering the raffle, verifying the validity of entries,

contacting winners and checking winners' identities, and marketing Bombay School. As certain information is required for us to run the raffle effectively, if you do not provide accurate information where we request, you may be disqualified from the raffle. Bombay School will collect, use and hold your information in accordance with our legal obligations, including under the Privacy Act 2020.

13. **Liability:** Subject to any applicable law that cannot be excluded, Bombay School and its employees and agents will not be liable for any loss or damage (whether in contract, tort (including negligence), under statute, equity or otherwise in connection with the raffle or the prize(s)). Without limiting the previous sentence, Bombay School is not responsible for any late, misdirected or incorrectly completed entries, or any technical malfunction, late payments, delay or loss of data that occurs in the course of the administration of the raffle, however caused.
14. **General:** Bombay School's decision regarding the raffle is final and no correspondence will be entered into. Bombay School may change these Terms at any time. If Bombay School cannot reasonably run the raffle as planned for any reason, Bombay School may cancel the raffle on 20 September 2024. In the event of cancellation of the raffle, all money will be refunded. Notice of cancellation of the raffle will be published in the Bombay School Newsletter and website, and in the Franklin County News on 26 September 2024.
